



UNITI RE-CONTRACTING PROMOTION

Terms & Conditions

The following terms and conditions apply if you undertake Uniti's Re-Contracting - Promotion:

- 1. Uniti's Re-Contracting - Promotion offers the following:** – any existing customer of Uniti, who's contract for services has come to an end, who then signs up for a further Uniti service - will receive a percentage discount of their monthly bill for the length of the new contract.
- 2. Terms and Conditions of Uniti's Re-Contracting- Promotion** – By participating in Uniti's Re-Contracting - Promotion:
 - a. you agree to be bound by Uniti's usual Terms and Conditions of Use, and
 - b. you also agree to be bound by the following Terms and Conditions of Uniti's Re-Contracting - Promotion.
- 3. Who can apply for Uniti's Re-Contracting- Promotion** – Uniti's Re-Contracting- Promotion is open to be accepted if:
 - a. You are an existing fixed wireless customer of Uniti; and
 - b. Your contract for services is within two months of ending or has come to an end; and
 - c. You then sign up for a further Uniti fixed wireless service; and
 - d. That service is for 12, 24 or 36 months.
- 4. What internet services are available on Uniti's Re-Contracting- Promotion** – Uniti's Re-Contracting- Promotion applies to Uniti's fixed wireless plans for residential and business internet services, but only to plans of 12, 24 or 36 months.
- 5. How long does Uniti's Re-Contracting - Promotion last** – Uniti's Re-Contracting - Promotion is open to be accepted until 11pm on 31st December 2019 or, if Uniti publishes notice on the Uniti website at Unitiwireless.com to the effect that Uniti's Re-Contracting - Promotion remains open until another time, then until that time.
- 6. What is on offer with Uniti's Re-Contracting - Promotion** – Under Uniti's Re-Contracting - Promotion each qualifying customer will be entitled to:
 - a. For a new 36 month contract, a 15% discount off the monthly invoice;
 - b. For a new 24 month contract, a 10% discount off the monthly invoice;
 - c. For a new 12 month contract, a 5% discount off the monthly invoice.

The discount will be applied monthly for the duration of the contract.



- 7. Cancellation fees 1** – If You cancel a contract for a service entered into under these conditions then a Cancellation Fee of \$35 per month remaining on the contract will apply.
- 8. Terms may change** – Uniti may change these Terms of Uniti’s Re-Contracting- Promotion at any time. Changes to the Terms of Uniti’s Re-Contracting - Promotion will be announced and current versions of Uniti’s Terms and Conditions of Use will be available at any time on Uniti’s web page.
- 9. Services may change or end**– Uniti may make modifications to the internet services it provides during Uniti’s Re-Contracting Promotion. Uniti may terminate the Uniti’s Re-Contracting Promotion at any time without reason or without notice. If Uniti’s Re-Contracting Promotion is terminated, then any discounts in place, will remain in place for the term of those contracts.
- 10. As many as you like people** – a customer may use Uniti’s Re-Contracting- Promotion as many times as they like.
