Terms & Conditions

Uniti's Upgrade 100- Promotion – Terms and Conditions

The following terms and conditions apply if you undertake Uniti's Upgrade 100- Promotion:

Uniti's Upgrade 100- Promotion offers the following: – any new customer of Uniti, who signs up for a Uniti LBNCo service for at least 12 or 18 months, and who enters a special promotional code – (EASTER19) – and who remains an LBNCo service customer of Uniti for a subsequent period - then the customer will receive the first month free and a discounted service for the second and third month of their service.

Terms and Conditions of Uniti's Upgrade 100- Promotion –By participating in Uniti's Upgrade 100- Promotion:

- A. you agree to be bound by Uniti's usual Terms and Conditions of Use, and
- B. you also agree to be bound by the following Terms and Conditions of Uniti's Upgrade 100- Promotion.

Who can apply for Uniti's Upgrade 100- Promotion – Uniti's Upgrade 100- Promotion is open to be accepted if you:

- A. are aged 16 years or over and have a current Australian residential address; and
- B. are not an existing customer of Uniti and you become a new existing customer of Uniti, or if you are an existing customer of Uniti and you re-sign for a further contract beyond the conclusion of your present contract; and
- C. sign up for a Uniti LBNCo service for at least 12 or 18 months; and
- D. on sign up you enter valid Unique Promotion Code when you sign up.

What internet services are available on Uniti's Upgrade 100- Promotion – Uniti's Upgrade 100- Promotion applies to Uniti's plans for LBNCo residential and business internet services, but only to plans of at least 12 – 18 months. Uniti's Upgrade 100- Promotion does not apply to Uniti's other residential or business plans, or to Uniti's premiums services. Any upgrades are additional to normal services and charges will be incurred for each upgrade.

How long does Uniti's Upgrade 100- Promotion last – Uniti's Upgrade 100- Promotion is open to be accepted until 11pm on 30th June 2019 or, if Uniti publishes notice on the Uniti website at Uniti.com.au to the effect that Uniti's Upgrade 100- Promotion remains open until another time, then until that time.



What is on offer with Uniti's Upgrade 100- Promotion – Under Uniti's Upgrade 100- Promotion each qualifying customer will be entitled to:

- A. the first month internet services for free; and
- B. the second and third month internet services at the discounted rate of the equivalent 25/52 Mbps service at \$69.95 per month; and
- C. after the end of the third month the internet service resumes at the standard fee for the 100/40 Mbps rate for the remainder of the 12 – 18 month term of \$99.95.

Terms may change – Uniti may change these Terms of Uniti's Upgrade 100- Promotion at any time. Changes to the Terms of Uniti's Upgrade 100- Promotion will be announced and current versions of Uniti's Terms and Conditions of Use will be available at any time on Uniti's web page.

Services may change or end– Uniti may make modifications to the internet services it provides during Uniti's Upgrade 100 Promotion. Uniti may terminate the Uniti's Upgrade 100 Promotion at any time without reason or without notice.

As many as you like people – a customer may use Uniti's Upgrade 100- Promotion as many times as they like.

But only one promotion at a time people – a customer may participate in Uniti's Upgrade 100- Promotion as many times as they like, but a customer may not use Uniti's Upgrade 100- Promotion together with any other promotion or incentive.
