Uniti's WA LBNCo Price Disruption - Promotion – Terms and Conditions

The following terms and conditions apply if you undertake Uniti's WA LBNCo Price Disruption - Promotion:

1. **Uniti's WA LBNCo Price Disruption - Promotion offers the following:** – any new customer of Uniti who signs up for a new contract, or any existing customer of Uniti who signs up for an extension to their contract, for a broadband Internet service with Uniti, via LBNCo to their building or premises, in Western Australia, for a contract of 12 - or 24-months duration - will receive:
 - a. The following discounted rates for a plan for broadband Internet services:
 - i. on a 25:5 plan - \$49.95 per month;
 - ii. on a 50:20 plan - \$59.95 per month;
 - iii. on a 100:40 plan - \$69.95 per month;
 - b. Unlimited data; and
 - c. No activation fee; and
 - d. No New Development Charge; and
 - e. A free router.

2. **Terms and Conditions of Uniti's WA LBNCo Price Disruption - Promotion –** By participating in Uniti's WA LBNCo Price Disruption - Promotion:
 - a. You agree to be bound by Uniti's Customer Service Agreement, and
 - b. You also agree to be bound by the following Terms and Conditions of Uniti's WA LBNCo Price Disruption - Promotion.

3. **Who can apply for Uniti's WA LBNCo Price Disruption - Promotion –** Uniti's WA LBNCo Price Disruption - Promotion is open to be accepted if:
 - a. Your building or premises are located in Western Australia; and
 - b. LBNCo are able to provide broadband Internet services to your building or premises; and
 - c. You sign up for a Uniti LBNCO Plan for broadband Internet services; and
 - d. You sign up for a 12 or 24 month contract; and
 - e. You sign up using any of the following codes: SUPERSAVE / SAVEBIG / BIGSAVEWA.

4. **What internet services are available on Uniti's WA LBNCo Price Disruption - Promotion –** Uniti's WA LBNCo Price Disruption - Promotion applies to Uniti's plans for residential and business Internet services.

5. **How long does Uniti's WA LBNCo Price Disruption - Promotion last** – Uniti's WA LBNCo Price Disruption - Promotion is open to be accepted until **11pm on 30st November 2019**, or, if Uniti publishes notice on the Uniti website at - unitiwireless.com - to the effect that Uniti's WA LBNCo Price Disruption - Promotion remains open until another time, then until that time.
6. **What is on offer with Uniti's WA LBNCo Price Disruption - Promotion** – Under Uniti's WA LBNCo Price Disruption - Promotion each qualifying customer will be eligible to receive:
- The following discounted rates for a plan for broadband Internet services:

 - on a 100:40 plan - \$69.95 per month;
 - Unlimited data; and
 - No activation fee; and
 - No New Development Charge; and
 - A free router.

At the end of the term of the contract the discount will cease.

7. **Cancellation fees** – If You cancel a contract for a service entered into under these Terms and Conditions of Uniti's WA LBNCo Price Disruption – Promotion, then a Cancellation Fee, of \$35 per month remaining on the term of the contract, will apply.
8. **Terms may change** – Uniti may change these Terms of Uniti's WA LBNCo Price Disruption - Promotion at any time. Changes to the Terms of Uniti's WA LBNCo Price Disruption - Promotion will be announced and current versions of Uniti's Terms and Conditions of Use will be available at any time on Uniti's web page.
9. **Services may change or end**– Uniti or LBNCo may make modifications to the internet services it provides during Uniti's WA LBNCo Price Disruption - Promotion. Uniti may terminate the Uniti's WA LBNCo Price Disruption - Promotion at any time without reason or without notice. If Uniti's WA LBNCo Price Disruption - Promotion is terminated, then any discounts in place, will remain in place for the term of those contracts.
10. **As many as you like people** – a customer may use Uniti's WA LBNCo Price Disruption - Promotion as many times as they like.
11. **No stacks on** – for any one service, a customer may only use Uniti's WA LBNCo Price Disruption - Promotion, and a customer may not use Uniti's WA LBNCo Price Disruption - Promotion together in conjunction with any other promotion.
12. **Western Australia & NBNCo services only** - Uniti's WA LBNCo Price Disruption – Promotion is open to be accepted by only residents of Western Australia, and to only those customers in WA who can obtain broadband Internet services to their building or premises via LBNCo infrastructure.
